Ireland Basketball Mission Trip - Tentative Itinerary

Friday June 23 *Depart Your Home City (early a.m.) - Arrive Dublin, Ireland (early morning)*

You will depart the USA on an early morning flight and will connect at a major airport and meet up with others from our group. You will then have an all-night flight to Ireland arriving early the next morning.

Saturday June 24 *Arrive Dublin, Ireland - City Tour*

Upon arrival at the Dublin International Airport you will be greeted by the staff of The Way Sports Ministries. After our group has all arrived, we will do a city tour of historic Dublin. You will walk the ancient streets of this storied city with you team. We plan to see St. Patrick's Cathedral, Ha'penny Bridge, Trinity College, Christ Church Cathedral and the famous shopping streets of old town Dublin. In the afternoon, we will drive to our hotel for the week to check-in

Sunday June 25 *Irish Church Service*

In the morning you will go to a local church service with some of the participants from our camp. After church we will spend the day with local players getting to know them before camp begins. This evening you will hang out with your team and maybe try some Irish Stew at a local restaurant.

Monday June 26 *Killarney Bike Ride - Evening Game*

Today we will take a Bike Ride through the Irish countryside. We will ride through the Killarney National Park where you will see Muckross Abbey Monestary built in the 15th Century. This 5 mile bike ride will be one of the highlights of your Ireland sightseeing experience. In the evening we will play our first game against a local club team from the area. After the first game we will have a "school yard pick" for new teams where we will play with the Irish players on each of our teams.

Tuesday June 27 *Blarney Castle - Evening Game*

In the early morning we will visit Blarney Castle. Here you will see one of the most famous castles in the world. Built in 1446, Blarney Castle is the place where you will have a chance to "kiss the Blarney Stone." We will then travel the short distance back to Cork where we will prepare for our second evening of games.

Wednesday June 28 *Dublin Basketball Camp - Day 1*

In the morning we will make the two hour drive back to Dublin where we will conduct an evening camp with local 12-18 year old athletes. During the camp you will have several opportunities to give your testimony and tell what Jesus has done in your life. Be prepared to share your faith.

Thursday June 29 *Dublin Basketball Camp - Day 2*

You will have the morning free to explore Dublin with your coach and team. In the evening we will continue our basketball camp. Tonight we will continue the good news message of Jesus with the children of Ireland.

Friday June 30 *Dublin Basketball Camp - Day 3 and Final Game*

Today we will conclude our basketball camp and have our final game with the local Irish players.

Saturday July 1 *Return to USA*

You and your teammates will depart for the USA in the early morning. You will arrive back in Oklahoma in the late evening.

Terms and Conditions

The Way Sports Ministries, hereafter known as the “TWSM,” acts only as agent for its suppliers and contractors providing transportation, accommodation and other related travel services. The TWSM assumes no responsibility or liability for any injury, death, damage, loss, or accident with any services resulting directly or indirectly from acts of God, strikes, government regulations, thefts, failure of any means, discrepancies or changes over which it has no control.

The TWSM applies all reasonable checks and measures in utmost good faith to ensure that details in the mission trip itinerary are carried out exactly as specified. However, changes, including, but not limited to, substitution of hotels of equal or similar quality and air carriers, may be made out of necessity. The TWSM also reserves the right to at its sole discretion change the dates and or location of a mission trip.

In case of dispute or litigation between a participant and an air carrier, the passenger contract issued together with the air ticket by the air carrier shall constitute the sole contract between the airlines and the passenger; the TWSM shall not be responsible for any delays, substitutions of equipment or any act of omission whatsoever by the carrier, its agent, and employees. In case of any type of dispute or litigation with the TWSM, its employees, or its agents, it is understood that any type of dispute or litigation shall be governed by the laws of the State of Oklahoma and the undersigned agrees and hereby voluntarily submits to the jurisdiction and venue of Muskogee County, Oklahoma.

Regardless of the reason, unused services during the mission trip, including hotel accommodation, ground transportation, domestic or international flights, meals, and sightseeing are neither refundable nor exchangeable.

Baggage and personal effects are the passenger’s own risks and it is the responsibility of the passenger to obtain insurance against loss or damage. All baggage charges are the responsibility of the passenger.

The TWSM and the operators involved in this program shall be exempt from all liability for losses or additional expenses in respect or any detention, delay, loss, damage, sickness, or injury, irrespective of the cause, including strikes, war, quarantine and whether or not directly or indirectly caused by any service provided or by a service provider, or by any property used or utilized by a service provider.

Any disability requiring special attention must be reported to the TWSM at the time the reservation is made. The TWSM will make reasonable attempts to accommodate the special needs of disabled mission trip participants, but it is not responsible in the event it is unable to do so, nor is it responsible for any denial of services by carriers, hotels, restaurants, or other independent suppliers. We regret that we cannot provide individual assistance to a participant for walking, dining, getting on and off motorcoaches and other transportation vehicles, or other personal needs. Participants who need such assistance must be accompanied by a qualified companion.

The participant acknowledges that TWSM has a requirement that the participant must purchase trip insurance that includes a medical evacuation clause, in connection with the missions trip.

Airline tickets and travel documents, will be sent regular ground delivery two to four weeks prior to departure, providing full payment has been received. You acknowledge that you has been informed that United States citizens traveling outside of the United States are required to obtain and carry a valid United States Passport. It is the responsibility of each mission trip participant to obtain a United State Passport prior to March 1, 2017.

The TWSM reserves the right to accept or reject any person as a mission trip participant and to make changes in the itinerary whenever the TWSM deems it necessary for the comfort, convenience, or safety of the mission participants, and to cancel a mission trip at any time. All claims against the TWSM must be filed in writing within 10 days after completion of the tour.

I, the undersigned, do hereby acknowledge that I am traveling as a participant or I am the parent or legal guardian of the Minor/Ward set out below and have fully read and understand this document and agree to indemnify and hold harmless, "The Way Sports Ministries" (hereinafter known as "TWSM"), its agents, employees, and assigns from any and all injury or loss of life whether to myself, my child, my ward, my heirs (including my spouse, if any), or my property that may occur in connection with the TWSM Summer Mission Trip. I further agree and waive any and all rights and claims that I, my child, my ward or my heirs (including my spouse, if any) may have against TWSM with regard to all liabilities (except those resulting from TWSM gross negligence or willful misconduct) losses, damages, costs and expenses (including attorney's fees) arising or resulting directly or indirectly from, TWSM I further acknowledge that said waiver has been signed at my own volition without any coercion, promise, or threat of any kind to myself, my friends or my family.

I further agree and consent, that in the unlikely event of an accident, injury or illness concerning the said Minor/Ward, TWSM, acting by and through its adult representatives, will use its best effort to contact the parent(s) or legal guardian(s) of Minor/Ward as soon as is reasonably possible.
